Standing business

 - Status of transfer of Treasurer duties from Robert to Judy is in process and they will arrange to meet to change signatures.
 - Robert & Judy will meet with the Membership committee to decide roles and responsibilities vis a vis membership dues and database reporting to LWVNJ and LWVUS
 - Evelyn will work with Pat S to submit the Final Grant Report to LWVUS for the 2020 Youth Registration Grant so that we can receive our final payment from LWVUS.
 - Robert will work on the budget for 2021-2022.

Diversity, Equity, Inclusion (DEI)

- · LWVSMC DEI Policy was read aloud by Wilma. Wilma asked about the meaning of the word 'geography' in the policy as it applied to DEI. Some discussion was held and the DEI team will follow up with LWVUS on this.
- The suggestion at the February meeting of creating a Spanish language version of the DEI policy was brought to LWVUS who created it and Rosemary Venter from our League translated our version.

Membership

Judy has completed the online membership form including paypal access. She will educate the Membership team on how this form can be used to harvest data about our members to better include them in our activities. Susan presented the proposed Bylaws changes and the Board agreed to what was being proposed with some additional changes. Peggy will send the Proposed Bylaws changes to the members 1 month prior to June 17th per the current Bylaws.

LWVNJ Convention – May 22, 2021

LWVSMC is entitled to 5 delegates. At the Board meeting, the following people agreed to represent us:

Peggy will send something to the membership about Convention urging our members to attend. There is no registration fee.

Evelyn moved and Annette seconded that we purchase an Ad for \$250 for the LWVNJ Convention. The motion carried. The Board decided that we would honor Pat and the Energizing Young Voters project. Peggy will contact Pat and will do the artwork for the ad.

LWVNJ is asking Leagues to submit a 2-minute video to showcase the work done this past year. Nancy agreed to choreograph/produce the video and Evelyn, Marie, Pat, Annette, Emmy and Bill Schroeter will be asked to participate. (Evelyn will contact Emmy about DEI and Susan will ask Bill to say something on Candidate Forums).

Voters Service

- Asbury Park Ballot Issue Nancy recommended that the League help prepare a fact sheet on the proposed Ballot issue on Rent Control which is being voted on in a special election on April 20th. Marie and Evelyn agreed to help Nancy put together Pros & Cons and explanatory language so it can be sent out electronically before the election.
- April 29th Day of Action Lisa lannucci is putting together a presentation that will be done over Zoom on 4/27 Redistricting & the Census Impact
- Monmouth Beach Candidates Forum non-partisan election. The forum is scheduled for April 28th over Zoom.
 Marianne Kligman, Greater Red Bank Area is managing. Anne Torre from GRBA is moderating. Evelyn will work with Marianne to ensure that the forum is promoted on our League's website i.e. big red button.
- Primary Candidate forums we are still waiting on final word of any competitive Primary races i.e. who candidates are but there are 4 Republican competitive races in our footprint that the Voters Service team will be reaching out to for potential forums and Vote411 participation.
- Voter Registration Booth The Ocean Grove Spring Fling is being held on May 1st and our members have arranged for us to have a booth. We hope to use the beanbag game. A suggestion was made to put the beanbags in plastic baggies and then clean the baggies in between. We hope to have a Primary fact sheet ready to hand out at this event.

UN Session on the Status of Women

Evelyn reported on a session she attended virtually at the UN as an official League delegate to the annual meeting of this group. She reported on the activity and that it was disappointing to her that the United States lags behind other countries in many areas when it comes to the Status of Women. Overall, however, the program was very beneficial.

Old Business

- Incorporation Status Evelyn is following up with LWVUS.
- Observer Corps Report Wilma observed the recording of a Township of Ocean Council workshop session and meeting on 3/25. These meetings are recorded and therefore can be viewed anytime if people can't go to the actual virtual meeting. Marie also reported that she had attended a meeting earlier this evening but not as a League observer. If an observer attends the actual meeting but their LWV button is not visible, they can change their name on the screen to include LWV.
- Facts and Issues interviews: Phillip Hensley new Policy Analyst from LWVNJ spoke on redistricting.
- Reenter-Register-Vote: Annette reported on her continued efforts to visit parole offices throughout NJ to educate and register returning citizens. She is making an overnight trip to Cumberland County to be at a site on a Monday morning.
- PR: The upcoming Hot Topic Access to the Ballot: Fighting Voter Suppression was advertised in the Coaster. Additional PR items are being planned to promote forums, Vote411, etc. as needed.
