### **Voter Education and Registration**

Team scheduled 20 meetings through 5 partners in 4 municipalities and reached 71 citizens **17 meetings** were completed – 5 in person, 9 zoom, 3 teleconference. 3 meetings were cancelled by partner organizations

## **Diversity, Equity, and Inclusion (DEI)**

*Team Co-Chairs – Diane Hara and Lois Kiley*

The DEI met on ZOOM, August 28, 2021, (attending – Lois, Diane, Annette, Wilma, Marie Curtis) and continued its ongoing discussion of terms relevant to understanding discriminatory practices across the United States. This month the terms were "redlining" and "a Karen":

**DEFINITION:** Redlining is the systematic denial of various services to residents of specific, often racially associated, neighborhoods or communities, either explicitly or through the selective raising of prices. The best-known examples of redlining have involved denial of financial services such as banking or insurance, other services such as health care or accessibility to places of business, e.g., supermarkets. In the case of retail businesses like supermarkets, purposely locating stores far away from targeted residents resulting in a redlining effect. Fifty years after the abolition of enslavement, local governments continued to legally enforce housing segregation through exclusionary zoning laws and city ordinances. The term "redlining" was coined in the late 1960s by **John McKnight**, a sociologist and community activist. It refers to the practice of marking a red line on a map to delineate the area **where banks would not invest**; later the term was applied to discrimination against a particular group of people (usually by race or sex) irrespective of geography.

**DEFINITION:** "A Karen" - Karen is a pejorative term used in the United States and other English-speaking countries for a woman perceived as entitled or demanding beyond the

scope of what is appropriate or necessary. A common stereotype is that of a white woman who uses her privilege to demand her own way at the expense of others.

## **OTHER DISCUSSION ITEMS**

- It was suggested that websites related to DEI information (e.g. terminology) might be a category on the League website to serve as a resource for members who are interested. Lois will contact Ted Dellinger to discuss the possibility of this idea being implemented.
- The T. Thomas Fortune Cultural Center was mentioned as a resource center for African American programs and a possible feature on Facts & Issues.
- Annette raised the issue of lack of access to Asian American communities for voter registration
- Discuss fundraising and increasing DEI membership for next meeting.

**August 12 meeting** lasted only 15 minutes.

- Public Hearing items: Open Space Resolution, Air Conditioning at the Municipal Gym, Drug Overdose Day were all approved with no public comment. Various expenditures (Police Department computer, vehicle improvements; Palaia Park roof replacement, cancelling real estate tax for veterans, road improvement, cannabis establishments, parking banned on Laurel Ave) all approved with no public comment.

### ***Ocean County Board of Commissioners – Observer: Anne Ugrovics***

**August 18 meeting** attended after an article in NJ Spotlight alerted us that the Commissioners would be awarding contracts for e Poll Books and voting machines.

- The Board voted 5 to 0 to award the contract to Dominion Voting Systems. Dominion is a Toronto based company. The key factor referenced is that the Dominion machine produces a paper ballot which the ES&S machine does not.
- There were very few people at the hearing. The Chair of the Board of Elections supports buying the Dominion voting machines. These machines will cost Ocean County \$2.6 million for Early Voting, which will be reimbursed by NJ.
- One person from the public spoke in opposition to the decision.
- According to the new Census there are 637,000 people living in Ocean County. The Board of Commissioners believes the count is short by 25,000 people

## **Energizing Young Voters (EYV)**

**Programs:** materials updates -Module 2 of FFV (*The Truth About Turnout*) has been updated with Census data figures from the 2020 election; former schools/teachers have been notified of new offerings and urged to get on the schedule.

**Collaborations:** Wilma Pfeffer (former CASA volunteer & employee; educator special needs) formulated early stages of plan to mentor foster kids; has met with director who will determine whether some issues can be worked out.

**Development/Funding** - "[story](#)" finished; looking for interested researchers to determine possible design and cost; have met with one from Rutgers (Camden).

**Presentations:** Citizenship education classes – (9/9 and 9/15); NJEA Convention (11/4-5) virtual and in-person; Dates TBD – Plainfield, NJ – multi-year implementation (all programs); Middletown HS South – multiple programs planned & implemented by 2 students under our guidance; Red Bank Regional HS – programs and voting simulation – planned by student; Four community and 4-year colleges in NY/NJ by adjunct professor who attended training workshops

**Future sustainability of EYV.** In scaling up in NJ, Pat envisions three regional districts each led by co-directors who will oversee the program in their region. The goal is to provide a transition in the future to maintain the program as its own entity, not "Pat's program." **Pat would like to hear from anyone with ideas on this.**

**Youth Advisory Board** membership terms will be 2 years; membership will be scheduled so there are always some experienced and some new members on the Board. **Students who wish to and can commit to a two-year term beginning this school year (9/21-8/23) should contact Pat.**

**Training:** All programs – YouTube recordings are available; will be posted on the website to assist teachers. They will be able to see the lesson being taught and interested adults commenting on them. Have a look yourself.
