# **Updates from the President**

**Club Express** – Analysis and due diligence paused during the run-up to the November election. Hope to have recommendation ready by November Board Meeting.

## **LWVSMC Legal Status** – No progress during October.

We received a notice from PayPal indicating that our Tax ID number isn't valid. Our use of PayPal may be restricted beginning in January 2022 because of new PayPal IRS reporting requirements.

We have learned that LWV of Western Monmouth has the same Legal Status issue that we have. LWV of The Greater Red Bank Area has a valid Tax ID number and is recognized by the IRS as a 501(c)(4).

**Slack** – Following up from the September report. As noted in that report, LWVNJ has set up a Slack account for internal (member to member) communications. I attended the introductory training for League Presidents with LWVNJ staff members Assatta Mann and Melissa Marks. I have used Slack in other organizations of which I am a member, so setting up was very straightforward. There is a channel for each Local League and channels being set up for projects. Using Slack isn't a requirement, but it may be effective for some purposes. I will send invitations to LWVSMC Board Members and Team Leaders after the November Board Meeting.
