Energizing Young Voters (EYV)

Director - Pat Supplee

Of note: I will meet with Sen. Vin Gopal (NJ), head of the NJ legislative education committee, on 5/10/22. Sen. Gopal's office reached out to learn more about our organization. I will provide him with an overview and answer his questions. I also hope to:

- 1. Thank him for sponsoring student initiated S2304. allowing a day of excused absence for middle and high school students who participate in a civic action; ask if there is any bipartisan support for the bill? What are the prospects for moving the bill out of committee? How we might take action that would help move it out of committee.
- 2. Thinking of equity issues for kids who don't go on to college, ask how young people learn about serving (e.g., internships) in legislative offices & activities (not campaigning, but the actual work of governing in NJ?)
- 3. Encourage a bill to expand discrete civics education requirements to high school in an effort to increase students' intention to vote and engage in democracy with civility so education occurs when the need for those attitudes and skills is imminent and for many students, is our last chance to influence them without partisanship.

Program notes:

- The first Smithsonian exhibit, *Voices and Votes: Democracy in America*, is finishing its stay at RCBC. We organized the docent program and had a table at the entrance to make people aware of EYV. EYV is providing docent training for the exhibit at Mercer County Community College, 5/3 from 7-8:30 via Zoom (https://us02web.zoom.us/j/88950862773) and in-person at the exhibit on 5/18. The Mercer exhibit opens on 5/19. The next event is at Atlantic Cape Community College. Upcoming venues over the rest of this year include Monmouth Museum during the summer, Union County CC and Middlesex County CC in the fall. Let me know if you would like to volunteer to be part of the events.
- The voting Simulation was held at Mercer Technical HS on 4/29/22. Students were trained to open, close and run the voting machines and serve as poll workers. The event was inspirational, to say the least, with several potential new members of EYV as presenters and board members. We will return next year.
- Webinar for the LWVNJ introduced over 30 new people to EYV. We took a deep dive into the Student Advocate Toolkit, helping participants modify the toolkit for their own county. Six modified toolkits now on our website.
- We will present at the LWVUS national convention in Denver in late June an overview of EYV programs and leadership opportunities, and hope to engage participants in the organization as presenters and volunteers.
- Across the Divide: Speak to be Understood is waiting for student-created videos, then is ready to pilot. Two middle schools have been lined up. Looking for at least one high school and one college/community college class to pilot for those age groups. Can be clubs or classes. Please LMK if your school might participate.

Collaborations:

- NJCDC Youth Outreach Committee in Paterson, NJ. We will likely be presenting all of our modules to the team of 30-50 high school students representing all Paterson public high schools, then engaging them as presenters in their own schools
- Art the Vote- (www.artthevoter.org), designed and developed by Jayne Mackta, one of our sponsors, asks young people to design nonpartisan postcards, posters, cartoon strips, tiktoks, etc. urging people to Get Out The Vote. Cash prizes and national exposure. Winning art will be mass produced as postcards to encourage potential voters for the 2022 and 2024 elections to get out the vote.
- NJ Score -(https://www.volunteermatch.org/search/org1161011.jsp) offers the help of retired experts to assist start-up organizations. Our match is with an attorney, Michael Pellegrino, who has provided helpful resources..

Development/Funding

- We are continuing our effort to engage people as sustaining supporters (asking for tax-deductible donations of \$10/month (or more) We are asking for matching corporate donations as well. Donations can be made through our website. Please urge anyone you know who believes in our vision and mission to consider donating. Every little bit counts, and big bits or matching grants enable us to operate and expand.
- We need someone to spearhead this effort. It is not my strength but is essential to our existence and growth. Please think of your networks and let me know if you have someone you can recommend.

Presentations: To date during SY 2021-22, we have held 51 presentations that reached 1256 students and 416 adults.

Future sustainability of EYV

• The Brookdale course, Board Development, with an eye towards moving EYV from a startup to a growth nonprofit entity was moderately helpful. We are in discussion with LWVNJ to try to determine the best way forward.

Internships

- Katy (fall '21) has been appointed to the Governor's Youth Advisory Council. She and representatives from 14 other organizations focusing on young people, advise the governor and his staff on issues of importance to young voters. Watch for updates in our next newsletter and on Facebook and Instagram.
- Gina (spring '21) is developing our fourth edition of our quarterly newsletter.
- Sheil Shah (spring '22) is focused on 1) adding GOTV efforts to our repertoire and 2) improving our social media presence. He has also begun developing a handbook so that future interns will have a clear sense of the job responsibilities and an easy-to-follow manual for completing needed tasks.
- Unpaid internship: Charlotte Parauda from Middletown South HS chose to work with EYV. Her goal was to become a program director: She has identified schools/teachers/community organizations, etc. interested in our programs, scheduling those and handling the administrative details associated. She has presented The Timeline of Suffrage to a middle school in Middletown, is in planning stages with other middle schools, and is hoping to expand her

repertoire to other presentations. She also helped organize and participated in a student voter registration drive
