# **Energizing Young Voters (EYV)**

Director - Pat Supplee

<u>Data:</u> Not only did NJ have the greatest increase among states across the nation in young voter turnout in the 2020 election – but Monmouth Co, where we have done most of our work, had the greatest increase of all counties in NJ. This is a correlation, not a cause/effect finding, but it is certainly intriguing and worth researching whether EYV has the impact we hope.

#### **Programs**:

- Smithsonian exhibit, Voices and Votes: Democracy in America, touring NJ
  - RCBC: opens on 4/1. Six docents trained; EYV tabling of ArtTheVote, Student Advocate Toolkit, and voter registration. Exhibit runs 4/5/22 to 5/5/22.
     (www.rcbc.edu/Smithsonian.)
  - Mercer County CC: EYV provides docent training for the exhibit, tabling, and module presentation.
  - Other venues to come over the rest of 2022 (Brookdale, Atlantic Cape, Middlesex and Union CC.)
- www.ArtTheVote.org is underway, co-sponsored by EYV, Vote by Design and Jayne Mackta.
   Cash prizes at different age levels; winning entries will be mass produced as postcards for mailing to friends and families for the 2022 and 2024 elections; also used as models for "make-your-own GOTV postcard" at future Smithsonian exhibits.

### **Materials updates:**

- Across the Divide: Speak to be Understood is waiting for student-created videos, then is ready
  to pilot. Two middle schools are lined up. Need one high school and one college/community
  college class to pilot for those age groups. Can be clubs or classes.
- Copyright challenge modifications: All programs accessible from the cloud except the teacher version (underway) of SATK have been reviewed and revised as needed.
