Many interesting presentations (Redistricting; Gerrymandering Legal Challenges; Abolish Electoral College; The National Popular Vote Bill would guarantee the Presidency to the candidate who receives the most popular

votes in all 50 states and the District of Columbia. It has been enacted into law in 12 states with 172 electoral votes. The bill will take effect when enacted by states with 98 more electoral votes. Transformation of LWVUS-more control over local leagues; Support of ERA-1 state needed, need to extend deadline; Gun Safety Resolution).
