ILO Board:

In order to support the two Hot Topic events and numerous candidate forums (County-level and for each of our Leagues) coming up in the next three months, I recommend that the ILO purchase the webinar version of Zoom that accommodates up to 500 participants and gives us maximum audience control. The three Leagues would share the platform, coordinating schedules to accommodate our individual and collective commitments. The cost is \$140/month for three months.

We need to get the publicity out ASAP for our August 13 Polling Hot Topic and we need a Zoom link and registration process to do so. So, if we are going to upgrade, we need to do it now. Susan, our Treasurer, supports the purchase and reports that the ILO has \$427 in its Education Fund to cover the projected cost of \$420. She assures us the Zoom purchase meets the criteria for using the Fund (educating/informing the public on critical public issues).
